We, the undersigned, stand in opposition of The Legends at KU, Phase II, and the request for a zoning change to increase the density for this development from 12 units per acre to the requested 13.7 units per acre. We believe that the integrity of our neighborhood would be compromised by the presence of over 25 contiguous acres of high-density multi-family dwellings. This expanded multi-family development will create a burden for our immediate area, will be a threat to the safety of the children who attend both Sunflower Elementary and Southwest Jr. High schools, and will have a negative impact on the property values in the area.

We ask that you vote **AGAINST** the proposed increase in density as requested for this development.


