## AGREEMENT BETWEEN THE CITY OF LAWRENCE, KANSAS AND THE DEVELOPER OF THE FOX CHASE SOUTH SUBDIVISION PROVIDING FOR THE INSTALLATION AND MAINTENANCE OF LANDSCAPING AT THE FOX CHASE SOUTH SUBDIVISION TRAFFIC CIRCLES

**THIS AGREEMENT** is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2005, by and between the City of Lawrence, Kansas (hereinafter referred to as the "City") and Marla, L.L.C., Remco, L.C., and Devco, Inc. (hereinafter collectively referred to as the "Developer").

<u>Section 1. Purpose.</u> The purpose of this Agreement is to provide for the installation and maintenance of landscaping of certain traffic circles on the property legally described as Fox Chase South, a subdivision in the City of Lawrence, Douglas County, Kansas. As set forth in the Final Plat recorded in the office of the Register of Deeds of Douglas County, Kansas on March 2, 2004 at Plat Book 17, Pages 664-665.

<u>Section 2. Traffic Circle Locations</u>. The traffic circles that will have landscaping installed and maintained are located at Harvard Road & Robinson Drive, Wagstaff Drive & Kanza Drive, Harvard Road & Plymouth Drive (east intersection); and, Wagstaff Drive & Waverly Drive, all in the Fox Chase South subdivision.

<u>Section 3. Installation of Landscaping.</u> The Developer shall pay to the City \$1,500 per traffic circle, for a total of \$6,000, for the installation and maintenance of landscaping at each traffic circle.

Section 4. Maintenance. The City will maintain the landscaping in the traffic circle to generally acceptable horticulture standards for a period of five (5) years beginning with the execution of this Agreement. If within five years from the execution of the Agreement, the City determines that: 1) the maintenance of landscaping a traffic circle is no longer in the public interest; or the 2) the traffic circle should be removed, the City shall refund to the Developer a pro rata amount of the \$1,500.00 per traffic circle based on the amount of the five year maintenance period. The City shall provide such maintenance after the expiration of the five year period as it determines appropriate. If the landscaping is removed by the City and the traffic circle remains, the City shall replace the landscaping with appropriate brick, stone or other permanent non-vegetative material.

<u>Section 5. Irrigation.</u> The City plans no irrigation to be installed in the traffic circle and the planting shall be of a general type and variety which shall not require routine irrigation.

<u>Section 6. City Approval.</u> The City shall solely approve the design of the landscaping in traffic circles.

<u>Section 7. Approval Criteria.</u> City staff shall use the size of the traffic circle and the ease of maintenance as criteria in approving the landscaping design.
