AFFIDAVIT OF COST FOR MACHINERY, EQUIPMENT AND NEW CONSTRUCTION

Serologicals Corporation, Inc. (d/b/a Celliance Lawrence, Inc.), through and by its duly appointed representative, hereby states as follows:

1. Pursuant to Kansas law, Serologicals Corporation (d/b/a Celliance Lawrence, Inc.) requested an exemption from ad valorem taxation equal to 80% of the property taxes assessed on machinery, equipment, and new construction to be used in the manufacturing of goods; said exemption approved by motion vote of the Governing Body of the City of Lawrence, Kansas, on January 28, 2003.

2. In fulfillment of the City of Lawrence approval of the tax exemption, Serologicals Corporation purchased, at the price listed, during years 2003 and 2004, the machinery, equipment, and new construction listed below:

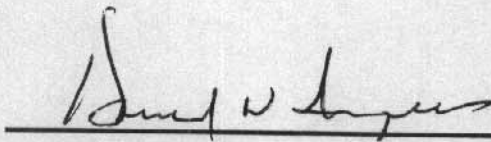

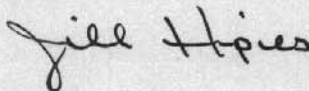
