Because of the limited sight, due to curvature of the 1400 block of
Lawrence Avenue, we, the undersigned, ask the Traffic and Safety
Commission to consider banning parking on the rest of the west
side of the street, north to the intersection of Applegate Court.

Such mitigating factors as the congestion at the busy intersection
of Bob Billings Parkway and Lawrence Avenue, the speed at
which cars turn on to Lawrence Avenue, the inability of trucks or
cars to pass parked vehicles (especially the garbage and emergency
vehicles which must travel this route) and the excessive speed of
cars going south on Lawrence Avenue cause concern to the
neighborhood. We fear that a serious accident is imminent.

We respectfully request consideration of our concerns.
