Re: Sunday Cereal Malt Beverage Sales

Dear Cereal Malt Beverage Retailer:

As you may know, the 2005 Kansas Legislature enacted Senate Bill 298 which essentially made applicable State liquor laws uniform. Senate Bill 298 also invalidated Lawrence's 2003 enacted Charter Ordinance 35 (authorizing certain Sunday liquor sales). In response to Senate Bill 298, on August 2, 2005, the Lawrence City Commission adopted Ordinance 7899 which authorizes both certain Sunday liquor sales and also certain Sunday cereal malt beverage sales. The effective date of Ordinance 7889 is November 18, 2005. After the effective date, sales of both alcoholic liquor at retail and sales of cereal malt beverage at retail in the original package will be allowed on any Sunday, except Christmas and Easter, between the hours of 12:00 noon and 8:00 p.m. In addition, sales of both alcoholic liquor and cereal malt beverage at retail in the original package will be allowed on Memorial Day, Independence Day, and Labor Day between the hours of 12:00 noon and 8:00 p.m.

Therefore, as a Cereal Malt Beverage Retailer, the sale at retail of cereal malt beverage in the original package will be allowed beginning Sunday, November 20, 2005 between the hours 12:00 noon and 8:00 p.m. Such sales will also be allowed on Memorial Day, Independence Day, and Labor Day. Sales of cereal malt beverages will continue to be prohibited on Easter Sunday, Thanksgiving Day, and Christmas Day.

Re: Sunday Liquor Sales

Dear Alcoholic Liquor Retailer:

As you may know, the 2005 Kansas Legislature enacted Senate Bill 298 which essentially made applicable State liquor laws uniform. Senate Bill 298 also invalidated the City of Lawrence's 2003 enacted Charter Ordinance 35 (authorizing certain Sunday liquor sales). In response to Senate Bill 298, on August 2, 2005, the Lawrence City Commission adopted Ordinance 7899 which authorizes both certain Sunday liquor sales and also certain Sunday cereal malt beverage sales. The effective date of Ordinance 7889 is November 18, 2005. After the effective date, sales of both alcoholic liquor at retail and sales of cereal malt beverage at retail in the original package will be allowed on any Sunday, except Christmas and Easter, between the hours of 12:00 noon and 8:00 p.m. In addition, sales of both alcoholic liquor and cereal malt beverage at retail in the original package will be allowed on Memorial Day, Independence Day, and Labor Day between the hours of 12:00 noon and 8:00 p.m.

Therefore, as an Alcoholic Liquor Retailer, Sunday liquor sales will continue; however, the hours of such legal sales will soon be changing. Beginning, Sunday November 20, 2005, the sale of alcoholic liquor on Sunday will only be allowed between the hours of 12:00 noon and 8:00 p.m. Such sales will also be allowed on Memorial Day, Independence Day, and Labor Day. Sales of alcoholic liquor will be prohibited on Easter Sunday, Thanksgiving Day, and Christmas Day.
