Though zoned RS-2 since 1966, the property had been non-conforming commercial until 1999, when the use voluntarily ended for three years. Because the non-conforming status was in dispute, in 2003 the Neighborhood negotiated with the new property owners, and supported their application for RO-2 zoning. But the owners violated their zoning and site plan, and built and rented the property for commercial use. After a drawn out appeals process with the BZA, the City Commission approved a revised site plan that forced the owners to correct the site plan violations, and use the property for no greater than office use.

The Neighborhood Plan calls for this property to be single family residential zoning, the Neighborhood rezoned four blocks immediately south from RM-1 to RS-2, and the Neighborhood convinced the City Commission to rezone a C-4 zoned lot two blocks east to RS-2. We already agreed to residence-office use at 1246 Haskell Ave., and do not want a commercial use precedent established there.
