

AN ORDINANCE CONSTITUTING A CONTRACT BETWEEN THE CITY OF LAWRENCE, DOUGLAS COUNTY, KANSAS, AND THE BOARD OF EDUCATION OF THE CITY OF LAWRENCE OF THE STATE OF KANSAS, RELATIVE TO THE TRANSFER OF RESPONSIBILITY FOR THE OPERATION OF THE LAWRENCE RECREATION COMMISSION AS WELL AS FUNDS AND PROPERTY USED BY THE RECREATION COMMISSION TO THE CITY OF LAWRENCE AND AUTHORIZING SUPPLEMENTAL AGREEMENTS FROM TIME TO TIME BETWEEN THE SCHOOL DISTRICT AND CITY RELATIVE TO THE USE OF SCHOOL PROPERTY AND OTHER MATTERS; ESTABLISHING A SEPARATE DEPARTMENT OF SAID CITY; PROVIDING FOR THE CONTINUATION OF THE PRESENT RECREATION COMMISSION AS THE RECREATION AND PARK ADVISORY BOARD OF SAID CITY; AND DIRECTING THE CITY AND THE SCHOOL BOARD UPON ACCEPTANCE OF THIS ORDINANCE TO DO ALL THINGS NECESSARY AND PROPER TO MAKE EFFECTIVE THE TERMINATION OF THE EXISTING SYSTEM AND THE CREATION OF THE NEW PUBLIC RECREATION SYSTEM AS PROVIDED BY SENATE BILL NO. 115 OF THE 1965 SESSION OF THE KANSAS LEGISLATURE.

WHEREAS, the Lawrence Recreation Commission was established under authority of Article 19, Chapter 12, of the Kansas Statutes Annotated, which provided for the operation of the Recreation System under joint control of the Board of Education of the City of Lawrence of the State of Kansas, and the City of Lawrence, Douglas County, Kansas; and

WHEREAS, Senate Bill No. 115 of the 1965 Session of the Kansas Legislature authorizes the termination of the Lawrence Recreation Commission and the establishment of a recreation system in the City, and provides for a maximum levy of 1 1/2 mills upon the assessed tangible property of the city for recreation purposes which the City may levy outside the aggregate tax levy limitations provided by law; and

WHEREAS, the Governing Body of the Board of Education of the City of Lawrence, of the State of Kansas, and the City of Lawrence, Douglas County, Kansas, after study and consultation, agree it would be in the best interests of the recreation program and the public generally to terminate the recreation commission as it now exists, and to make recreation a function exclusively of said City, using such school facilities as may be available; and

WHEREAS, the City desires to retain the services of the members of the present Recreation Commission, in an advisory capacity, to be known as the City Recreation and Park Advisory Board.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF LAWRENCE, KANSAS:

SECTION I: This Ordinance shall constitute a contract between said Board of Education and the City, for the termination of the Lawrence Recreation Commission as of December 31, 1965, from which date, the entire

responsibility for the operation of a public recreation system in the City of Lawrence shall be vested in the City exclusively.

SECTION II: The Governing Body of the City will appoint all of the presently acting members of the Recreation Commission for their unexpired terms, and the Commissioners, so appointed, will be known as the Recreation and Park Advisory Board of the City of Lawrence, Douglas County, Kansas. Such Board shall make recommendations to the Governing Body of said City of Lawrence on all matters referred to it concerning recreational facilities and programs, including all major proposals for construction, reconstruction, acquisition, and improvement of public parks.

SECTION III: All property of the Lawrence Recreation Commission shall be transferred and delivered to the City of Lawrence on the 31st day of December, 1965, and the City will budget for the next fiscal year for all recreational activities.

SECTION IV: This Ordinance shall take effect and be in force from and after its publication in the official City paper, and upon its acceptance by the Board of Education of the City of Lawrence, of the State of Kansas.
