The Sustainability Action Network urges you to decline approving the Lawrence Loop Alignment Study, given that BNSF Railroad has denied the Study's preferred alignment along their mainline track from the Burroughs Creek Trail to the Burcham Park Trail. Railroads consider public safety of paramount concern on and along their properties.

Whether or not the City of Lawrence can negotiate an alignment agreement with BNSF in any context, this Loop Alignment Study in it's current form is premature, and should not be the basis of further engineering study, TIP proposals, or CIP proposals.

This Loop Alignment Study was flawed from the beginning. It needs to be redrafted. The engineering consultant firm did not follow best practices. A professional approach would be to study alignment designs that were first determined to be legally and technically feasible and met the bicycle-pedestrian objectives, and only then conduct a public preference poll. Instead the consultant issued a poll based on romanticized public notions of the Loop's transportation needs, and neighborhood and downtown access, and then tried to pigeonhole the preferred alignment choice into a legal and technical form.

This draft of the Lawrence Loop Alignment Study more closely reflects the work of a public relations company than of a professional engineering company. Please disapprove it, and any further steps toward actual trail development, until the study can be redone.
