Meeting called to order by Phil Collison. Minutes for April, May, and June were reviewed. Cindy moved they be accepted, Aaron seconded. Minutes were approved. Minutes still needing to be reviewed: February, March, July.

Thank you to Delaware Commons for allowing ELNA to hold its meetings in their facility during the summer months.

Regan of Culinaria discussed the changes occurring to their business. They are in the process of expanding from a catering business to offering dining for lunch (Tuesday thru Saturday) and dinner (Thursday thru Saturday). Dinner will be small plates and beer/wine will be available. Menu will be healthy Mediterranean cuisine. They will be going before the city commission on 9/5 for a waiver on alcohol as the restaurant is within 400 ft of both a church and school.

Phil will be contacting people to help with the Beer tent on 8/25. Last meeting the following volunteered: Penny Blackburn (shift), Scott Blackburn, Pam Blackburn, Jennifer (shift), Mike Anderson, Phil Collison.

Home Tour: Eric passed out the list of finalist houses. He is asking board members to vote on their 4 favorite old houses and 4 favorite new/combo houses. Votes need to be returned by Sunday.

Final Friday at the MB House was a great success. Wonder treats by Lane and her daughters. Probably won't be open on August Final Friday due to Beer tent money maker.

Downtown grocery: the neighbors residing on RI across from the proposed location met to discuss concerns. They are:

1. Entrance/Exit on RI. This is directly across from the Entrance/exit on NH, making it a direct pass thru. The Entrance/Exit on RI will increase the traffic on a now limited access street. Concerns about noise, headlights shining into homes and general safety due to increased traffic.
2. The proposed building is to be built adjacent to NH, 7th, and RI. Residents would like more green space between the building and RI. They would like some noise buffering trees to be between the building and the fence/sidewalk on the west side of RI.
3. The proposed building has 2 stories of apartments above the grocery. The apartments on the east side have balconies. These will have direct line of sight into all stories of the RI homes.
4. Neighbors would like to see the Entrance/Exit on RI to be moved to 7th st to alleviate the above concerns.
5. It is projected the number of cars on RI will increase to 1000 / day.
6. Neighbors are concerned about the limitation of direct sunlight they now have by this 4 story building being built so close to their homes.
7. It has been said that the northeast corner of this complex will contain the loading dock and trash bins. Smell will be a factor.
8. Many of the homes on RI have had restorative basement work. The task of excavating and building the 2 story parking garage and general supports for the building is disruptive to the stability of the ground. Pounding the pilings shakes the ground and will most likely cause damage to nearby homes. Will there be provisions to pay for damages?

9. RI is currently a limited access street that is mostly one way. It was one-way fairly recently. The Bicycle advisory committee had it changed to 2 way to accommodate bicycles without consulting the neighbors. So what happens now? Neighbors have asked but gotten mixed answers from the city.
10. Truck delivery entrance is too close to the corner of 7th & RI. Concern about safety of walkers & bikers.
11. The proposed Compton Conference center to the north of this location is where employees will park.
12. If tax incentives are given, can the affordable housing apartments be made permanently affordable?
There is the concern that it will all become upscale apartments far too soon.
13. What safeguards are in place to keep the grocery store affordable in future years?

This goes to the HRC on 8/17. The neighbors would like a letter of support from ELNA. It was moved by Phil, seconded by Aaron, that Phil will write a letter voicing concerns of the project and asking for details on how they will be addressed before continuing to support this project. The concerns raised by the RI St residents are troubling. The traffic and massing of this project are inappropriate for the Historic Environs of 7th & RI. Motion passed.

Conservation overlay committee has been formed including Dave, Chris, Jennifer, Aaron, Phil & KT.

East 9th: the city commission has a proposal on the consent agenda to approve money for the design to Bartlett & West. Aaron moved to submit a letter that ELNA has an expectation of public input and that the neighborhood will be part of designs of public works projects. Seconded by KT. Motion passed. Letter to be written by Phil and submitted early to the City Commission. It was noted there is again a troubling trend of public meetings are scheduled without much notice and during non-traditional times. ELNA feels better communication and notice needs to be happening.

Coordinator: Working on next newsletter. Additionally, by request, the facebook discussion group has been merged with the fan page. Will work out the kinks.

Cindy moved to adjourn the meeting. Johni seconded. Meeting was adjourned.

Dennis Constance of Justice Matters & Affordable Housing spoke about the upcoming sales tax question to be voted on in November. Question 3 is asking the voters to approve a .05% tax to be put into the affordable housing trust fund. Lawrence is currently 4000 units short in affordable housing. This will not be an additional tax. This amount was previously dedicated to the transit hub. He would like everyone to support this question in the November election.

Home tour scheduled for 10/21 from 10 – 4 was discussed. Eric has asked the owners for commitment. 4 of 10 have committed. 2 most likely will. Suggested price is \$15 in advance, \$20 at the door.

Block party is 9/30.

The city commission voted to allow the downtown grocery store project to apply for incentives. The grocer will only commit to 5 years due to the current changing of the food market business. HRC was dismayed by the mass and scale of the structure and has asked for changes.

East 9th: city & LAC are looking for ways to use remaining money from grant.

NY School book fair is in November. Cindy moved, KT seconded to donate to the fair.

Treasurer reported there is \$3023.56 in the checking account.

Reminder that the October meeting is when candidates declare for the ELNA board elections in November.

From the President, September, 2017

I just dropped off my plastic bags at Dillon's, and they've got Halloween stuff for sale. Free State's Octoberfest is out. There are even leaves falling from the trees! Holy cow! Is it Fall already? Our August weather sure has been odd. Almost pleasant (meaning it has been fairly cool for August, especially after a blistering July!). There are back to school photos on Facebook, and drivers going the wrong way on the one ways (watch out!). Fall *must* be right around the corner. The summer lull has given way to a number of City projects that will impact East Lawrence. Here is a rundown.



The 9th street rebuild is moving forward. It was approved to go to a 3rd-party engineering firm to turn the concept drawings into a detailed ready to build from design document with much better cost estimates. Currently there is 2.5 million allocated for the plan, and the City is pretty confident they will come in under that number. They voted to nix burying the electrical lines when they discovered that would have caused up to a one year delay with the start of the construction of the street. They expect the build to begin next spring with a simple plan that will mostly retain a very similar streetscape to what is already there, along with a sidewalk upgrade to 6 foot wide on each side of the street. No word yet on who will pay for those sidewalks.

There is a new Arts Center Grant in the works that could fund local artists doing art across the City. We hope to continue working with the Arts Center to help make this a project that benefits our entire Arts Town.

The Downtown Grocery Store is moving through City channels. The City Commission voted to accept the request for incentives to move through the process. Also, in end of August, the HRC deferred accepting the design, asking the developer to re-submit plans that more closely aligned with downtown design standards and integrated into the residential neighborhood to the east. The Grocery Store is tied to a development of apartments and therefore will be pretty tricky to raise at the proposed location. The tough part here is, though we may love the use of the building as a grocery store to serve our neighborhood and surrounding neighborhoods in our food desert, uses do change over time, and buildings endure. Design must take this enduring edifice into consideration. I have faith that our City processes are up for the challenge to make this a win-win for all.

Because it is almost Fall, that means our East Lawrence Block Party is right around the corner, too! Watch for details on what to know if you're attending and how you can volunteer. Our raffle will be better, the potluck will be better, the music, the ambience! It will all be better this year! And all because of YOU! September 30th at Hobbs Park, 5-9pm. I hope to see you there!

What's Up with That Header?

Return to your roots, East Lawrence! You may notice the header image of this newsletter is different than usual. It's actually the same header as was used in the September 1983 issue.

In 1983, East Lawrence citizens were fighting the City over the demolition of a large swath of the north western portion of East Lawrence to make way for the (now) infamous Haskell Loop. Within the next several years, numerous abandoned plots in East Lawrence were being sold by the City, by lottery and for phenomenally low prices, in contrast to currently rising land costs. It was a very different environment in East Lawrence in 1983, yet that header still seems relevant. We still like our bikes and dogs and ball at Hobbs Park.

As a bonus, here's a little excerpt from the September 1983 East Lawrence News:

PS: The idea of a twelve page newsletter makes us sweat...

"Bigger and Better

This edition of the EAST LAWRENCE NEWS is the first to make use of two new pieces of equipment purchased with revenue from the sale of ads.

A waxing machine makes layout and paste up much faster neater and more accurate than the rubber cement method formerly used.

A bulk film loader enables the newsletter to purchase film in 100 foot reels rather than one small roll at a time, providing for tremendous savings.

These two pieces of equipment cost less than the price of the newsletter's first ever full page ad, purchased by the Jazzhaus this month.

With pasteup easier, photos cheaper, and ad revenue increasing, the EAST LAWRENCE NEWS will soon be expanding to a 12-page format. "

Survey findings along with recommendations will be developed by Allegro Training & Consulting staff and reviewed by a diverse / multicultural / intersectional community review board. The final findings and recommendations will be reported in general terms with relevant data including (but not limited to) gender identity, sexual orientation, ethnicity, religion, socioeconomics, etc. As part of the Lawrence Police Departments commitment to excellence in Community Policing, they are anticipating using the results of this survey in their ongoing strategic planning in the areas of: Recruiting & Hiring, Officer/Civilian Development, Citizen Engagement and Measurement & Evaluation tools.

The City will load trucks and trailers. The City cannot load trucks with ladder racks.

Bring a tarp to secure woodchips in trucks and trailers to prevent littering the roadway.

Compost and woodchips are not intended for commercial applications, but rather for the citizens of Lawrence.

Location: 1420 E. 11th Street which is east of 11th and Haskell Avenue, over the railroad tracks

Compost and woodchips are for SELF LOAD ONLY, except the FIRST SATURDAYS of each month (April-October) the city will load truck and trailers (no ladder racks).

Pick-up truck or trailer loads will be \$10 per load and small quantities will be free. CASH only.

What is Compost?

Compost consists of decayed organic matter and has been proven to be extremely successful as a natural soil amendment. Lawrence Community Compost is made from the yard trimmings and small woody debris collected curbside on Monday mornings, as well as grass clippings, leaves, and woody debris from some commercial lawn care providers.

What is Mulch?

Mulch is a material used to cover the soil. Most mulches are organic (woodchips, unfinished compost, straw) but inorganics such as lava rock or limestone can add an appealing, low maintenance touch. Good mulch conserves water by reducing moisture evaporation from the soil. The woodchips the City sells are made from tree materials brought in from residential and commercial sources. Note: Woodchips may contain Emerald Ash Borer. Transportation within counties quarantined for Emerald Ash Borer is okay. Do not transport woodchips outside of the listed quarantined counties: Atchison, Doniphan, Douglas, Jefferson, Johnson, Leavenworth and Wyandotte.

Conservation Overlays – A Summary

Per an ELNA Board request, and courtesy of research by KT Walsh, here's a summary of what a Conservation Overlay is. Thanks owed also to the Historic Preservation Foundation of North Carolina.

What is a Conservation Overlay?

A Neighborhood Conservation Overlay District (NCOD) is a zoning tool used to preserve, revitalize, protect and enhance significant older areas within a community beyond what is specified in the standard code. The conservation overlay regulations are applied in addition to standard zoning regulations and will usually take precedence. NCOD regulations will differ from neighborhood to neighborhood, depending on the area's character and needs.

What's the difference between a Historic District and a NCOD?

Both a NCOD and a historic district are overlay districts; however, a NCOD will typically regulate fewer features and will focus more on significant character defining features, such as lot size, building height, setbacks, streetscapes, and tree protection. Unlike historic districts, NCOD rarely consider specific elements, such as windows, building materials, colors, and decorative details. In addition, most NCODs do not include demolition delays, a tool utilized in historic districts.

What are the criteria needed for an NCOD?

The exact criteria for an NCOD in any specific location must be acquired from a city's local planning department.

But, for example, the City of Chapel Hill, North Carolina utilizes the following requirements:

Area must include one block face (all lots on one side of a block, at minimum)

Area must have been developed at least 25 years before applying for an NCO

75% of the land in proposed area must be presently improved

Area must create a consistent setting, character, or association by possessing at least one of the following:

Scale, size, type of construction, or distinctive building material

Lot layouts, setbacks, street layouts, alleys or sidewalks

Special natural or streetscape characteristics (i.e. creek beds, parks, gardens, street landscaping)

Abuts or links designated historic landmarks or districts

Area must be mostly residential in nature and character

How is an NCOD formed?

Again, the local planning department determines the specific processes required to form a Neighborhood Conservation Overlay District. For example, the city of Winston-Salem, North Carolina follows these steps:

1. Pre-application to determine eligibility
2. Submit to City Planning Staff
3. Include: boundary of proposed district (identify each property within the district), written endorsement by the Neighborhood Association Executive Committee and a copy of the current bylaws, original petition with signatures of 55% of property owners in a district
4. If all above is approved, following steps may continue:
 - a. Inventory including description of natural and built features of area (2 maps supplied by planning staff – national register district neighborhoods may be included)
 - b. planning staff assigned to review to make sure properly completed
 - c. conservation standards list constructed
 - d. final submission, notification, and adoption by the City

Lawrence Loop Alignment Study

The city continues to be a leader in the construction and development of trails and paths which allow our residents access to all parts of the community by walking or biking. The Lawrence Loop is a project that, when completed, will provide a continuous 22-mile trail around the city limits. Public Works and the Parks and Recreation Department are working together to develop the Lawrence Loop as an amenity for the community. The city has added two sections to the trail in 2016 alone including trails through Rock Chalk Park and another section called the Baldwin Creek Trail, also in northwest Lawrence.

We are conducting an alternative analysis to determine the feasibility of alignments for two incomplete sections of bikeway between the north end of the Burroughs Creek Rail Trail along 11th Street to the Shared Use Path in Burcham Park and the west side of the Sandra Shaw Trail to the Peterson Road Shared Use Path.

The first open house was held on June 12, 2017. Public input is currently under review. A second open house will be held September 18th, from 5:30-7:30 pm, at the Lawrence Public Library.

The Lawrence Loop now has a Facebook page.
