There, I was able to meet and coordinate a presentation time with Shannon Oury from the Lawrence/Douglas County Housing Authority concerning their plan to establish a crisis/center additional housing within the neighborhood. She will be our February meeting to further expand on that project.

Our PNA Plan Working Group continues to develop projects to keep the vision of our neighborhood plan going. We are in the early stages of development for the April Neighborhood Clean up with working group possibly taking the lead on coordination. As always, we continue to recruit interested neighbors to the working group to maintain and diversify our numbers.

We'll continue to find touch points where we can collaborate with other neighborhood entities including LMH. Also, we are in the early development stage for neighborhood initiatives in 2019.

Approvals of September and October Meeting Outcomes

Guest Presentation - Shawn Gross and Derrick Smith, City of Lawrence Public Affairs Office

They provided statistics on crime and other disturbances in Pinckney. Of note, the top call was about animals; 54 were welfare checks, 61 domestic disturbances, 54 suspicious activity (3 with a weapon) 44 disturbance calls (6 with a weapon), 29 trespassing, 38 traffic accidents (includes 6th St.) 80 vehicle investigations, 55 pedestrian checks PNA asked for statistics for certain areas to review a heat map of traffic and violence, which may help guide Walk Pinckney activities. **S. Gross and D. Smith to provide.** Safe holiday practices and the new police facility, which will be located at 6th & Wakarusa were discussed. To report neighborhood issues, go to NRO@PLD.org.

Treasurer's Report

PNA has a \$1,153 checking account balance; \$122.64 in the savings account; and \$352.54 in petty cash. The CDBG grant has a balance of \$2,738. PNA needs additional funding to publish its newsletter.

- **Trunk or Treat** - Great event with many people (more than last year: approx. 200) and the most trunks to-date with \$240 donated to Heartland Community Health.
